## MEMORANDUM

**TO:** Heads and Acting Heads of Departments and Agencies

**DATE:** February 27, 2025  
**RE:** Agency Reporting to OPM for Fiscal Year 2024 Taxpayer-Funded Union Time Use

---

### I. Introduction

President Trump has promised to restore efficiency and accountability in the Federal Government. Doing so is crucial to improve the ability of agencies to deliver mission outcomes, provide excellent service, and effectively steward taxpayer dollars. In support of this objective, the U.S. Office of Personnel Management (OPM) is requiring agencies subject to the Federal Service Labor-Management Relations Statute (the Statute)<sup>1</sup> to administer the Statute in a manner consistent with the requirements of an effective and efficient government and, consistent with this objective and 5 U.S.C. § 7131(d), to authorize taxpayer-funded union time<sup>2</sup> only in amounts that are reasonable, necessary, and in the public interest and to monitor its use to see that it is used efficiently.

### II. Agency Reporting Requirements

This memorandum includes two data requests with separate deadlines.

**Request #1:** By **March 14, 2025**, Agencies are required to submit the below taxpayer-funded union time information for Fiscal Year 2024 (i.e., October 1, 2023, through September 30, 2024).<sup>3</sup> In large part, these are the same data elements that Agencies were required to submit for the [Fiscal Year 2019 report](#).

Aggregate Data (*see Tab A in attached template*):

1. The purposes for which the agency has authorized the use of taxpayer-funded union time (i.e., Term Negotiations, Mid-Term Negotiations, Dispute Resolution, General Labor-Management Relations)
2. The amounts of time used for each purpose of taxpayer-funded union time;

3. The total number of bargaining unit employees as of September 30, 2024;
4. The total value of the free or discounted use of government property for labor organizations or individuals on taxpayer-funded union time;
5. Any expenses the agency paid for activities conducted on taxpayer-funded union time; and
6. The amount of any reimbursement paid by the labor organizations for the use of government property.

Employee Data (*see Tab B in attached template*):

1. The job title (as listed on position description) and total compensation (cost of salary and benefits) of each employee who has used taxpayer-funded union time in the fiscal year;
2. The total number of hours each employee received pay and the total number of hours spent on taxpayer-funded union time;
3. Employee's position description number; and
4. Employee's official duty station as listed on their SF-50.

**Request #2** (*see Tab C in attached template*): By **April 1, 2025**, Agencies are required to submit the below taxpayer-funded union time (TFUT) information for Fiscal Year 2024 (October 1, 2023, through September 30, 2024).

1. For each employee listed in Tab B who has used taxpayer-funded union time in the fiscal year, please provide a copy of their position descriptions;<sup>4</sup>
2. For each employee listed in Tab B who has used taxpayer-funded union time in the fiscal year, please note whether they were eligible to telework or work remotely prior to President Trump's January 20, 2025, Presidential Memorandum, "Return to In-Person Work"; and if so, how many days per pay period were they required to go to the office? (*please update in columns J and K in Tab B*)
3. How many hours did each agency permit labor organizations, or employees of the agency for whom TFUT was authorized, to use that agency real property (e.g., offices, cubicles, or other space within an agency facility) at no cost or at a discounted rate? How much was each agency reimbursed with respect to the use of agency real property provided at no cost or at a discounted rate?
4. How much did each agency permit and reimburse labor organizations or employees authorized for TFUT for expenses related to purchasing new office supplies, upgrading equipment, or covering construction and renovation costs for office space designated for collective bargaining unit use?

5. As it relates to each agency's TFUT use, if there was an increase in the total cost, hours claimed, or eligible employees between FY23 and FY24, please provide a detailed explanation of the circumstances giving rise to any increase.

### **III. Data Submission**

The standardized form for the agency submission of the annual report is attached to this memorandum. The fiscal year 2024 standardized form must be submitted electronically to [awr@opm.gov](mailto:awr@opm.gov). The submission deadline is no later than March 14, 2025 for Request #1 and no later than April 1, 2025 for Request #2. For each request, one consolidated report is required from each department or agency head covering all bargaining units in the agency.
