Subject: Annual Data Call for Pathways Programs and Early Career Talent Hiring Reporting FY 2024

Under Section 6 of Executive Order 14035: Diversity, Equity, Inclusion, and Accessibility in the Federal Workforce, the Biden-Harris Administration directs agencies to increase availability of paid internships, fellowships, apprenticeships, and other early career programs.

The Pathways Programs, which include the Internship, Recent Graduates, and Presidential Management Fellows Programs, provide clear paths to Federal paid internships for students and potential careers in the Federal sector for students and recent graduates. Agencies using the Pathways Programs must adhere to the annual reporting requirements in accordance with 5 CFR 362.109.

Each agency, in coordination with its components/bureaus, must provide the following data:

- 1. Hiring projections for FY 2024 for each of the Pathways Programs. Agencies are not required to consolidate their bureaus'/components' reports, and can submit the data using any format to Pathways@opm.gov.
- 2. Indicate recruiting practices your agency/component uses to attract diverse talent through the Pathways Programs. Refer to <u>Guide to Internships</u>, <u>Fellowships</u>, <u>Apprenticeships</u>, and <u>Other Programs</u> for information about effective recruitment and outreach strategies and practices.
- 3. Include other programs your agency/component/bureau plans to use in FY 2024 to provide employment opportunities to early career talent. Examples include the: Workforce Recruitment Program, Post Secondary Student Hiring Authority, College Graduate Hiring Authority, agency-specific internship programs, Third Party Student Programs, Student Volunteer Programs, Apprenticeships, Cyber Corps Scholarship for Service, etc.

We recommend that you engage your agency's Pathways Programs Officers and Presidential Management Fellows (PMF) Program Coordinators to assist you with this request.
