Subject:	Human Capital Framework Evaluator Training

The U.S. Office of Personnel Management will conduct evaluator training courses virtually and in-person during FY 2024. Our training focuses on the Human Capital Framework and three phases of the evaluation process (i.e., planning, implementing, and reporting) with real-world, practical exercises. The no cost training course is intended for agency employees who participate in human resources evaluations associated with their agency's Human Capital Framework evaluation system.

In-person sessions will be held from 9:30 a.m. to 4:00 p.m. local time, Tuesday through Friday for the following dates and locations:

Virtual sessions will be held Monday through Friday on the following dates and times:

- January 22-26, 2024, 9:30 a.m. to 4:00 p.m. ET
- February 5-9, 2024, 9:30 a.m. to 4:00 p.m. CT
- August 5-9, 2024, 9:30 a.m. to 4:00 p.m. ET
- September 23-27, 2024, 9:30am to 4:00pm CT

Classroom space is limited to 25 participants per course. Priority is given to participants who have not previously attended. Cancellations should be submitted at least two weeks prior to the course start date. As cancellations occur, we will offer the training slot to the next available registrant on the course waitlist. Training slots may not be held or transferred to other individuals. We recommend coordinating nominations for the course with agency Accountability Program Managers to prioritize agency training needs.
