Subject: Delegated Examining Training

In a continuing effort to enhance the Delegated Examining Training administered by the Office of Personnel Management, we are launching a new approach targeted at meeting the needs of Federal agencies in terms of successfully performing competitive examining work under delegated examining authority.

Beginning October 2001, Delegated Examining Training will be offered at Employment Service locations nationwide. This approach will provide a streamlined process that will offer greater accessibility to this training, as well as maximize the ability to train a greater number of agency representatives on a monthly basis. Agencies will now have the flexibility of selecting the location and schedule that meets their needs, yet consistently receive the high quality training that we have provided in the past. Agencies are encouraged to attend the training offered based upon the schedule provided. If special training becomes necessary to meet an agency's needs, we are prepared to provide this training on a reimbursable basis. In the next several weeks, we will feature on our website, the attached training curriculum for FY 2002, along with specific location and contact information. Agencies will have the ability to contact a representative at the desired location directly, to register for future training sessions.
